ECONOMIC FORECASTERS REPORT SIGNIFICANT OPTIMISM & PREDICT PROGRESS FOR 2020

CenterState CEO's 2020 Economic Forecast for Central New York predicts progress and significant optimism for this year. The report was released at CEO's 2020 Economic Forecast Breakfast last month to a record-breaking crowd of more than 750 business and community leaders.

The 2020 Economic Forecast report includes the perspectives and projections of CenterState CEO members and business leaders

from 17 industry sectors, and includes data on exporting, industry and employment trends.

The event's keynote speaker, M&T Bank Regional

The event's keynote speaker, M&T Bank Regional Economist Gary Keith, provided an analytic assessment of national and regional economic trends from the past year, and an outlook into 2020. According to Keith, there is much to be optimistic about through 2020.

"After battling choppy performance earlier in the decade, CenterState New York's regional growth expanded solidly for the third consecutive year in 2019. Private sector employers added 7,100 new jobs, more than double the year-ago total and the largest gain

in several years," said Keith. "However, as regional unemployment rates continue to hover near an all-time low, it is essential that we have enough productive, well-trained workers available to meet employer needs. Continued public and private sector collaboration to address labor and skill shortages is critically important to sustaining and building upon the region's recent economic progress."

CenterState CEO President Rob Simpson highlighted that the optimism shared by Gary Keith was echoed by this year's forecasters. He challenged the community to set a new vision for what could be achieved over the next decade and begin the work needed to ensure ongoing success.

"As we begin this new decade we do so with confidence that the regional economy is headed in the right direction," said Simpson. "There is both statistical and anecdotal evidence that reinforces this optimism.

CenterState CEO 2020 Legislative Agenda

The annual CenterState CEO Legislative Agenda sets CEO's key legislative and policy priorities for the year. It is aligned with regional priorities and projects, input from members and expected legislative initiatives at the state and federal levels.

FEDERAL

Key federal issues include infrastructure, unmanned systems and improving global competitiveness for products and services produced in the region. CenterState CEO supports tariff reductions and agreement on fair trade rules to benefit local companies that export, as well as resources to assist more companies to enter export markets. Infrastructure priorities include Interstate 81 and passage of a new Federal Surface Transportation bill. For the unmanned systems industry, swifter approvals by the FAA combined with moving past one-off waivers to timely rule-making will provide

meaningful progress for the unmanned systems industry in the U.S., especially the regional unmanned systems ecosystem.

STATE

Priority policies in Albany focus on the areas of economic development, infrastructure, health care and climate change.

Economic Development: Support for reducing New York's small business tax rate from 6.5% to 4% for corporations with fewer than 100 employees and \$390,000 in net income; enhancing the New York State Historic Preservation Tax Credit to increase transferability and increased credit for smaller projects; and supporting another round of funding for the Regional Economic Development Councils and Downtown Revitalization Initiative.

Infrastructure: Continued support to advance the re-development of I-81, including completion of the project's Environmental Impact Statement; additional investments in the Erie Canal corridor; accelerated expansion of rural broadband access; and creation of the UAS "Skydome" test facility for small drone development.

Health Care: Support for efforts to achieve universal health care coverage in New York, while maintaining consumer choice and promoting the health of the region's health care sector.

Climate Change: With New York's Climate Leadership and Community Protection Act in place, CenterState CEO is actively working through its Government Relations Committee to ensure that member voices are heard and the region is well positioned to realize new opportunities from this law and mitigate any challenges that it may pose. CEO is also engaging on the northeast regional Transportation and Climate Initiative. See page 7 for details.

In addition to these priority areas, CenterState CEO is engaged on measures in the areas of labor, housing, energy and more.

CEO'S WORK TRAIN TEAM HELPS GUIDE SYRACUSE BUILD

In his January State of the City address, Mayor Ben Walsh announced Syracuse Build, a new initiative designed to support Syracuse's construction boom by connecting capable job seekers from Syracuse's historically marginalized communities with career pathways in construction-related fields.

To capitalize on the opportunity from high impact projects such as continued development in the urban core, the University Hill, and the impending construction of the Community Grid, the City of Syracuse convened anchor partners including Onondaga County and Syracuse University to develop Syracuse Build.

With the support of a National Fund for Workforce Solutions grant, funded by the Ballmer Group, CenterState CEO's Work Train team has served as the initiative's lead planning consultant. CenterState CEO staff have helped drive the design and incubation of a new approach to holistically address the needs of

employers and job seekers, while removing barriers that prevent both of these groups from reaching their full potential. The result of this work is a partnership that connects local government, anchor institutions and construction firms to a coordinated network of community, training and workforce partners.

Syracuse Build will be led by a steering committee and managed by CNY Works, Central New York's single point of entry to the workforce system whose mission is to bring businesses, job seekers, and training providers together with the goal of providing skilled workers for every business and employment for every job seeker. By the end of 2020, Syracuse Build aims to place 100 people into construction industry jobs and work has already begun in the community under this partnership driven initiative.

GENIUS NY FINALS NIGHT TO AWARD \$3 MILLION, APRIL 22

Five startups in the GENIUS NY program recently arrived in Syracuse to compete in the fourth round of the world's largest business accelerator for unmanned systems. The teams will pitch their companies on April 22 to a panel of judges before a live audience. This exciting event will draw more than 500 people and include past GENIUS NY teams, local UAS companies and startups from The Tech Garden.

GENIUS NY is housed at CenterState CEO's Tech Garden. With support from New York state, the accelerator annually invests \$3 million in five startups, including a grand prize of \$1 million and four \$500,000 awards.

Since 2013 GENIUS NY has invested \$9 million in 17 startups. The accelerator is based in Syracuse and is a short drive to the New York UAS Test Site managed by NUAIR, one of only seven in the nation.

The seeds of this progress were planted nearly a decade ago when we revised our approach to more strategically target investments in key projects and industries, and advance those efforts with a spirit of collaboration and a shared vision. As we look to the future we must tackle the opportunities and challenges before us with the same focus and dedication to ensure that this economic progress continues."

Through a survey and focus groups conducted by third-party research firm Research & Marketing Strategies, Inc., forecasters reflected on the growth they experienced in 2019 and shared their predictions for 2020:

- 74% described their business in 2019 as being strong or very strong.
- 76% described their outlook for the strength of their business in 2020 as strong or very strong.
- 70% anticipate increased sales or revenue in 2020; down 5% from 2019 projections.
- 60% expect to expand product and services in 2020; no change from 2019 projections.
- 49% expect to increase capital investments; no change from 2019 projections.
- 65% expect an increase in jobs and hiring in 2020; up 10% from 2019 projections.

The forecasters also identified several environmental factors expected to have impact in 2020.

Innovations within an industry, and the advancement of technology and its impact on business operations, was noted as the top positive environmental factor in 2020.

Government policy and regulatory issues; the ability to attract and retain the right people in the right position, and the ability to invest in and develop the skills of the existing workforce, were noted as top factors expected to negatively impact businesses in 2020.

Forecasters acknowledged that strong local and national economic trends and job opportunities impacted their projections for their business and the regional economy. Organizations are also developing new products and services to drive continued success and be more competitive. The unmanned systems, IoT, big data and sensing sectors are experiencing strong growth and advancing technology, including automation. Additionally, an increase in the use of data has created efficiencies and enabled companies to create new solutions for clients.

Forecasters also noted several challenges and pressures for 2020, including: attracting and retaining skilled talent; tariffs that drive up costs for exporters and create uncertainty in the supply chain; the ability of small businesses and startups to access capital for growth; uncertainty at the federal level, which impacts businesses ability to plan and make continued progress; and pressures on businesses from New York state regulations.

CNY REGIONAL COUNCIL RECEIVES \$86.2 MILLION AWARD

The Central New York (CNY) region was awarded \$86.2 million for 93 projects in the ninth round of the Regional Economic Development Councils (REDC) in December. The Central New York region has received the most investment out of all 10 council regions since the inception of this statewide competitive funding

"Being selected once again as an REDC Top Performer illustrates that this year's projects — many driven by our members - will continue to create jobs, strengthen industry opportunities and deliver strong ROI on the state's investment," said Rob Simpson, president of CenterState CEO. "CenterState CEO members' projects represent 54% of the funded projects in round nine, estimated to add more than 450 jobs to the region and retain over 5,200 jobs, a testament to the integral role our members play in advancing our long-term inclusive economic development strategies for the region."

The funding for this latest round of projects allows for further implementation of the CNYREDC's strategic plan to continue the region's forward momentum for the long term.

Also in Round 9, downtown Fulton was selected as CNY's Downtown Revitalization Initiative (DRI) recipient, receiving \$10 million for its strategic investment and revitalization plan, part of an effort to improve the urban vitality of city centers across New York state. Fulton leaders aims to "Blaze New Trails" by building on recent momentum in its historic downtown waterfront and NYS 481 corridor, enhancing natural and cultural attractions, and continuing to grow opportunity in local health, service, and manufacturing industries. With a boost from DRI, the city will strengthen the infrastructure necessary to support downtown businesses and create recreational and cultural opportunities attractive to visitors and residents.

"I am proud to serve on the council to advocate for our region, and I applaud Central New York regional council cochairs Randy Wolken and Deborah Stanley for their ongoing leadership, vision and commitment," said Simpson.

SkyDome Coming to Griffiss

Gov. Andrew Cuomo announced in his 2020 State of the State Address that \$9 million is being allocated to fund Oneida County's SkyDome project at Griffiss International Airport.

The 55,000-square-foot-facility will be the largest, state-of-the art, indoor/outdoor instrumented unmanned aircraft systems (UAS) cyber physical experimentation environment in the country. It will support year-round development and testing of advanced UAS technologies, including artificial intelligence-based flight control, autonomous swarms, resilient, cyber-secure command and control,

vehicle-to-vehicle communication and counter UAS techniques.

The indoor SkyDome will be 200 feet long, 250 feet wide and 50 feet high connected to a netted outdoor facility that is 150 feet long, 250 feet wide and 72 feet high, which will be reconfigurable to support the testing of more than 100 small UAS simultaneously. This environment will enable the development of UAS applications in a safe environment with the ability to connect the experimentation into NY UAS Instrumented Corridor, a true microcosm of the future National Air Space.

TRANSPORTATION AND CLIMATE INITIATIVE, MEMBER INPUT NEEDED BY FEB. 28

There is a new regional initiative taking shape that will impact business and personal transportation: the Transportation and Climate Initiative (TCI). It includes all states from Maine to Virginia, including New York and the District of Columbia.



The goal is to implement a cooperative plan to reduce greenhouse gas (GHG) emissions from the transportation sector and its 52 million registered vehicles in the region. The

focus is on vehicles as a source of GHG emissions because since 1990, transportation has become the largest source of GHG emissions, now contributing 40% of the pollutants.

The TCI proposes a cap on the amount of carbon emissions permitted and imposes a fee on distributors of fossil fuels. The proceeds of that fee are used to invest in low carbon transportation alternatives. It is anticipated that the TCI could reduce GHG emissions by 20% with a 5 cent per gallon increase in fuel, 22% with a 9 cent increase and 25% with a 17 cent per gallon increase.

In December, the TCI states released a draft memorandum of understanding (MOU) to implement this system. The draft MOU is open for public comment until February 28. For the remainder of 2020, the states will hold hearings; legislation will be drafted in 2021; with possible implementation in January 2022.

Industries that are largely reliant on freight movement, trucking and distribution operations, and businesses that need employees to come to a central work place will be impacted.

Proponents argue that in addition to reducing GHG emissions, which contribute to climate change, the reduction will also lead to better health outcomes; improvements in the region's cities; and more. Opponents cite the tax has increased costs for businesses and individuals; an imbalance of benefits with costs being generated in more rural areas; among others.

Akrobotix (GENIUS NY '17) was awarded a National Science Foundation (NSF) Small Business Innovation Research (SBIR) Phase I grant to enable safe and reliable autonomous unmanned flight operations for drones. NSF supports research and development of deep technologies — those that are based on discoveries in fundamental science and engineering.

"This NSF SBIR grant will enable Akrobotix to develop and commercialize its unique, core technology: a universal, platformindependent autopilot for autonomous vehicles," said Amit Sanyal, co-founder of Akrobotix.

As the diversity and number of applications of autonomous



unmanned aircraft systems (UAS) grows across industries, platform-independent solutions to onboard autonomy become increasingly important. Akrobotix plans to advance in platformindependent onboard autonomy, particularly for small unmanned aircraft systems (sUAS), to enable safety and reliability of UAS. In 2017, Akrobotix won \$250,000 in the GENIUS NY competition at The Tech Garden.

Oneida Indian Nation

Since the 1993 opening of its flagship property, Turning Stone Resort Casino, the Oneida Indian Nation, has become one of the region's largest employers and leading tourism destinations. What began with gaming has grown into a diversified collection of enterprises that includes fine dining, hospitality, retail, outdoor recreation and live entertainment.

As an engine of local job creation and prosperity, the Nation has stayed true to its mission of continual reinvestment in the Oneida people and in Central New York.

In 2019, Oneida Nation Enterprises created new jobs, dispensed more than \$140 million in payroll, spent tens of millions of dollars on local vendor spending and paid a record \$70 million to the state of New York – the most of any upstate casino.

This \$70 million is part of the Oneida Indian Nation's 2013 settlement agreement with the state of New York and Madison and Oneida counties to officially end all disputes among the respective parties. As part of this agreement, the state receives 25 percent of the Nation's slot machine revenues. A portion of this is redistributed to the 10 surrounding counties within the Nation's gaming exclusivity zone.

Since 2013, Nation settlement payments have totaled more than \$300 million, a significant portion of which supports the region's public safety, schools, roads and social services. The revenues have also enabled Oneida County to freeze property tax rates for six years straight.

Arts and cultural programs have been supported as well. St. Joseph's Health Amphitheater at Lakeview is a direct recipient of the Nation's annual payment stream to Onondaga County – roughly \$2.5 million a year. This 17,500-seat concert venue was constructed in 2014 with municipal bonds backed by those payments.

As the Nation grows, so will its commitment to the region – thus ensuring Central New York's success and vitality for the future.






