community prosper. Syracuse's proposal builds on the recentlyannounced Syracuse Surge, an unprecedented series of investments in tech infrastructure that will position Syracuse as one of America's "smartest" cities and a leader in the New Economy.

The Advancing Cities Challenge attracted more than 250 proposals from 143 communities across 45 states and territories. The four other winning cities are Chicago, Illinois; Louisville, Kentucky; Miami, Florida; and San Diego, California. Syracuse was selected because its proposal successfully outlined local coalitions of elected, business and nonprofit leaders working together to address major social and economic challenges, such as employment barriers, financial insecurity and neighborhood disinvestment.

ANNUAL MEETING: LEAD WITH INTENTION TO CREATE GREAT COMPANIES AND COMMUNITIES

In his annual address to membership last month, CenterState CEO President Robert Simpson spoke of the real and immediate opportunities, no longer on the horizon, but taking place right now in the region, and the need to lead with intention to influence change and achieve true impact.

SENTIENT BLUE WINS GENIUS NY \$1M GRAND PRIZE

Sentient Blue, a team from Italy, is the winner of the \$1 million grand prize from round three of the GENIUS NY accelerator. The GENIUS NY program, which is administered by The Tech Garden and CenterState CEO, and funded by New York state, is the world's largest business competition focused on unmanned systems, cross-connected platforms and other technology-based sectors.

During the event held at the Marriott Syracuse Downtown, the five teams pitched their business plans to a panel of judges and to a live audience. Following the pitches, all five competitors were awarded an investment: EagleHawk One from Buffalo, New York; Vermeer from Brooklyn, New York; ResilienX from Syracuse; and CivDrone from Israel, each were awarded investments of \$500,000. The teams will use these investments to continue to accelerate their growth and expand their presence in the region. ResilienX was also named the crowd favorite in a live poll taken during the event.

"We are honored to have been selected as the winner of GENIUS NY 2019," said Saif Akanni, CEO and CTO of Sentient Blue. "We would like to thank everyone at GENIUS NY for sharing our vision of revolutionizing the drone industry with our hybrid technology. We are thrilled to be a part of the GENIUS NY ecosystem. This award is a real milestone for Sentient Blue; it will allow us to establish the company in Central New York and accelerate our growth and development."



"Finals Night and the \$3 million awarded to the five teams, marks the beginning of the second phase of the GENIUS NY program," said Rick Clonan, vice president of innovation and entrepreneurship at CenterState CEO. "Our teams will now use the input received from judges to refine their business plans to accelerate their growth. We look forward to several more months of helping these teams make connections and seeing their incredible progress."

SYRACUSECOE SELECTS FIVE COMPANIES TO RECEIVE FUNDING TO ADVANCE INNOVATIONS

Five companies from the CenterState New York region will receive awards from the latest round of the SyracuseCoE Innovation Fund competition. Four recipients are startup firms and members of The Clean Tech Center, operated by CenterState CEO. SyracuseCoE's Innovation Fund helps Partner firms to commercialize potentially transformative innovations. The five winners are:

Cocoon Construct, based at The Clean Tech Center, is developing a prefabricated panelized system for whole-building deep energy retrofits in New York state and will create jobs at multiple manufacturers throughout the product's supply chain.

Ducted Turbines International, located in Potsdam and at the CleanTech Center, is commercializing a ducted turbine technology and will use the funding to address key aspects of the system that are not readily available.

Edson Innovative Power, LLC, based at The Clean Tech Center, will perform advanced thermal simulation and analysis on its product to drive design optimization and design verification prior to moving to production.

Farm to Flame Energy, a student-led venture from Syracuse
University and CleanTech Center member, will construct a
prototype of a biomass-powered electricity generator that is

capable of using any dry biomass feedstock.



LC Drives, located in Potsdam,

is developing the next generation of electric motors that are smaller, lighter and more efficient. This project will help scale the machine design and related manufacturing equipment.

"These awards highlight CenterState New York's vibrant ecosystem for innovations and entrepreneurship in environmental and energy systems," said Ed Bogucz, SyracuseCoE executive director, and associate professor of mechanical and aerospace engineering at Syracuse University. "These awards help companies bridge the gap to commercialization of new products."

SyracuseCoE is NYS's Center of Excellence for Environmental and Energy Systems. Award funding is provided by industry members of the SyracuseCoE Partner Program. The five awards in the current round total \$47,146. To date, these awards total \$407,345 to support 37 clean energy projects at 24 companies in New York.

All current **SyracuseCoE Partners** are eligible. The next call for proposals is in August. Applicants submit a proposal and then pitch to a panel of reviewers. For more information, contact Tammy Rosanio at **tlrosani@syr.edu**.



New York State 2020 Budget Priority Highlights

The enacted Fiscal Year 2020 New York State Budget — \$175.5

billion — contains policy items in addition to the state's traditional financial plan, including items that are priority issues and concerns for CenterState CEO and its members. Below are some highlights:

Real Property Tax Cap Made Permanent

Since its inception, the 2% real property tax cap has saved home and business owners millions of dollars in real property taxes. With the passage of the fiscal year 2020 budget, the tax cap is now permanent.

Upstate Public Transit - For the

last few years, CENTRO and other Upstate transit systems received yearly gap funding to maintain their current operation. The new 6% tax on car rentals in Upstate New York provides sustainable funding of an expected \$22 million annually. CENTRO was facing a \$3.5 million deficit for its upcoming fiscal year. This fee also provides \$11 million in 2019 to cover current shortfalls. This comes at a time when the demand is increasing for public transit to connect employers and employees to their jobs beyond their current service footprint and schedules, as well as planning for the future of the Interstate 81 viaduct.

Enhancements to the State's Historic Preservation Tax

Credit (HPTC) – This effective and popular tax credit program is
being enhanced in several ways. All historic buildings within two
categories are now permanently included in the HPTC: (1) National
Register buildings within New York State Parks and State Historic

Sites and (2) qualified properties in cities with a population less than one million with at least a 15% poverty threshold. This last change supersedes the previous criteria by census tract. Areas of some Upstate cities were facing disqualification as some census tracts would no longer be qualified or were next to qualified neighborhoods.

Funding for an Accurate Census Count – Additional funding (\$20 million) is in the budget to augment outreach for the upcoming 2020 census. A complete count is essential for New York state in order to receive the appropriate amount of federal funding, and seats in the House of Representatives, among other key matters, for the next decade. A less than complete count will cost New York in reduced federal support and the potential loss of another seat or two in the House.

Expansion of Prevailing Wage – Again this year, legislation was introduced to expand the state's prevailing wage mandate to privately developed projects that receive any incentive or tax credit, with a major push by the sponsors to have this included in the state budget legislation. The additional cost of prevailing wage generally far exceeds the value of local municipal and state incentives combined, for this reason CenterState CEO actively opposes this legislation. While it was not included in the budget, the governor and legislative leaders in both houses have publicly supported it. It is now expected to be a major post-budget focus in Albany.






