\$900B COVID-19 RELIEF PACKAGE: ADDITIONAL PPP, EIDL FUNDING FOR BUSINESSES

Federal agencies begin 2021 with the task of implementing a \$900 billion COVID-19 relief package approved by Congress and signed by President Trump in late December, which includes several provisions to support

small businesses and individuals, and funding for testing and vaccine distribution that will be vital to the nation's economic recovery in the coming months.

Here are some of the key provisions of the package:

The largest section of the package focuses on assistance for small business. Businesses and nonprofit organizations with 300 or fewer employees are eligible for a second round of the Paycheck Protection Program (PPP), if they demonstrate a loss



of 25% of gross receipts in any quarter during 2020 when compared to the same quarter in 2019. PPP has been extended to several business and nonprofit classifications that were initially excluded from the program.

The relief package also provides \$20 billion to reopen the Economic Injury Disaster Loan (EIDL) Advance grant program. This popular program provides EIDL Advance grants of up to \$10,000 to eligible small businesses and nonprofits. Businesses that received previous EIDL Advance grants are eligible to receive a second grant, up to the maximum amount, if their first award was less than \$10,000.

Arts and cultural institutions — including live performance venues, independent movie theaters and others — are eligible to apply to the Small Business Administration (SBA) for a special grant program open to this industry.

Tax benefits in the package include extension of the Employee Retention Tax Credit through July 1, 2021. The extended credit now applies to businesses with up to 500 employees and reduces the year-over-year decline in gross receipts from 50% to 20%.

Debt relief assistance is also available to COVID-impacted businesses with loans under the SBA 7(a) and 504 programs.

Albany 2021: New Faces, New Issues

When New York begins its 2021 state legislative session Jan. 6, Albany will look very different from when it opened session in 2020, including beginning this year with largely remote operations. Due to the COVID-19 pandemic, new priorities will impact the way the legislature and the administration operate. New issues will also rise to the top of the agenda, while others will recede. There will also be new faces.

Central New York has a new state senator, filling the seat vacated by Bob Antonacci, who is now a judge. John Mannion, of Geddes, now represents the 50th senate district and becomes part of a freshman class that provides Democrats with a new veto-proof majority, with 42 of the Senate's 63 seats. Mannion plans to focus on jobs, economic development and education.

In the 126th Assembly district, Assemblyman Gary Finch, who represented the district for more than 20 years, has retired. Republican John Lemondes, of LaFayette, won the race to succeed Finch. Lemondes plans to focus on reducing taxes and spending, as well as economic development, particularly for agriculture and small businesses.

The pandemic and New York's economic recovery will dominate the agenda as the state works to resolve a more than \$10 billion budget deficit for the current fiscal year and the likelihood of another large deficit for the next fiscal year. Simply maintaining operations will be a challenge in the near term.

As a result, Governor Cuomo and state legislators will seek new revenue sources. First, New York and many states are looking to Washington for additional COVID relief and stimulus funding. Beyond federal funding, several options to raise new state revenues are under consideration including: marijuana legalization, a "millionaire's tax," remote sports betting and new casinos in the downstate region. Budget cuts are also under consideration and are likely, if there is no additional federal relief funding.

Also due to the pandemic, issues like election reforms, homelessness prevention, aid for small business and business interruption insurance are likely to become more prominent, while contentious and costly issues like the adoption of a statewide single-payer health care system are less likely to be top agenda items.

GENIUS NY: NOW ACCEPTING APPLICATIONS FOR ROUND 5

GENIUS NY — the world's largest business accelerator competition focused on unmanned systems — is now accepting applications for its fifth round. The year-long, in-residence accelerator program is operated out of CenterState CEO's Tech Garden in downtown Syracuse and will invest \$3 million in five finalist companies, including a grand prize of \$1 million. GENIUS NY is funded through the *CNY Rising* Upstate Revitalization Initiative, the region's award-winning strategic plan to generate robust economic growth and community development. The program also offers resources, programming and networking



opportunities to assist innovative startups with the tools they need to take advantage of emerging opportunities. GENIUS NY participants are required to operate their business in Central New York for at least one year.

Applications are currently being accepted at www.geniusny.com through March 31, 2021, from tech startups focused on unmanned systems, internet of things (IoT), big data and robotics. Subsets may include precision and remote sensing, data collection and analytics, guidance or communication systems, and sensors, among other technological categories.

"The GENIUS NY accelerator program has proven to be a critical element of the region's growing UAS and UTM ecosystem," said Jeff Fuchsberg, director of GENIUS NY. "At a time when our community has felt the economic challenges caused by COVID-19 firsthand, it is exciting to see investment in this sector, which is a proven jobs creator. The teams we will welcome through this round will be selected in no small part because of their potential to create jobs and support the region's growing tech sector."

Applications will be evaluated by a panel of judges and 15 to 20 semi-finalists will be selected to present demos and pitches this spring. Five companies will advance to participate in the competition, which is structured as a unique programmed incubator and accelerator experience. These five teams will enter the in-residence accelerator at CenterState CEO's Tech Garden in 2021, and will be immersed in the incubator's events, resource pool and mentoring. Applicants should be prepared to relocate to Central New York to participate in the program starting in May. Delays to the start of the program may be created by COVID-19.

Geopipe of New York City was named as the round four winner of the GENIUS NY \$1 million grand prize in <u>September 2020</u>. Other round four winners who are now operating in Central New York include BotsAndUs from the United Kingdom; Droneseed from Seattle, Washington; Skyy Network from Australia; and Eget Liber from Syracuse.

"Startups from four prior cohorts have come from around the world to participate in this program and be immersed in Central New York's strong unmanned systems ecosystem. I have no doubt that this round's finalists will find this region to be the best place to grow their company," said Rob Simpson, president of CenterState CEO. Our support will enable them to create high-skilled jobs and contribute to the regional economy."

A number of new funding sources are available to support businesses and nonprofit organizations affected by the COVID-19 pandemic. Please review the list below and follow the provided links to determine whether your business or nonprofit is eligible to apply.



FEDERAL

USDA Rural Energy for America Program (REAP)

Provides Renewable Energy Systems, Energy Efficiency Improvements and Energy Efficient Equipment and Systems assistance to agricultural producers and rural small businesses. Applications for funding from current appropriations are due on March 31, 2021. Applications and more information can be obtained through the New York State Rural Development Office, through the Federal Register Notice of Solicitation of Applications (NOSA), or through grants.gov (search "USDA Rural Energy for America").

STATE/REGIONAL

SEDCO COVID-19 Small Business Grant Program

The Syracuse Economic Development Corporation (SEDCO) is working to secure additional funds to expand this program and provide additional grant awards beyond the initial \$150,000 funding. This program awards grants of between \$2,500 and \$10,000 to small businesses in the city of Syracuse with 50 or fewer employees. Neighborhood organizations that provide support to local small businesses are eligible for grants up to \$25,000. Funds can be used to purchase outdoor equipment such as tents, awnings, enclosures, or heaters, and can include technology systems for online ordering and e-commerce. Expenditures can also be made on HVAC upgrades and sanitizing supplies or equipment; marketing and advertising to promote takeout and online options; and indoor equipment to optimize social distancing and safe operations. Click here for an informational webinar. Applicants not awarded in the first round do not need to resubmit. Applications would be reviewed in the order in which they are or were received. Applicants must fill out the application, additional required materials (listed on Page 3 of the SEDCO application), and an informational sheet all available here. COMMUNITY FUNDS, FOUNDATIONS, NONPROFIT SUPPORT

Comcast RISE

A multi-year commitment to provide marketing, creative, media, and technology services to Black, Indigenous and People of Color (BIPOC)-owned small businesses that were disproportionately affected by extended closures in the wake of the pandemic, as well as continued social unrest across the country. Selected businesses could receive consulting, media, and/or creative production services and/or a technology makeover. Grant funding is anticipated to be available in 2021. GoFundMe Coronavirus Small Business Relief Initiative

Provides \$500 matching grants for U.S. GoFundMe fundraisers benefiting small businesses. The business must be independently owned and operated and not nationally dominant in the field of operation for that business and must use funds to either help care for its employees/workers or pay ongoing business expenses. Fundraisers must have at least \$500 raised; have the business owner set up as the beneficiary to the fundraiser (if they aren't raising funds themselves); have withdrawals set up; and add the hashtag #smallbusinessrelief to the fundraiser story. LISC-Lowe's Rural Relief Small Business Grants

Rounds 10 and 11 application windows for the LISC Rural Relief Small Business grants are open December 29, 2020 – January 5, 2021 and January 26, 2021 – February 2, 2021, respectively. This program provides between \$5,000 and \$20,000 to small businesses located in rural communities (population of 50,000 or less). The grants target small businesses in underserved communities, including those led by entrepreneurs of color and women and veteran-owned businesses that often lack access to flexible, affordable capital. Grants can be used for: payables to include rent and utilities; meeting payroll (to include the applicant); paying outstanding debt to vendors; other immediate operational costs. Visit LISC's website for more details on selection criteria and subsequent rounds of funding, including FAQs. Register to be notified when each round opens and gain access to the application.

Licensing International Small Business Global Grants Fund

This program is designed to help small business employers in the brand licensing sector to create and maintain safe, healthy and sustainable work environments during and beyond the global pandemic. This fund provides \$5,000 grants to companies with between three and 20 employees that have been harmed financially by the COVID-19 pandemic. Applications are due January 29, 2021. Partnership for Community Development Rural Business Technology Grants

\$1,000 to \$10,000 grants designed to use technology to help farm- and forestry-based businesses grow. Eligible projects will incorporate new technology into your business model to assist with logistics and marketing. Open to farm- and forestry-based businesses in the towns of Hamilton, Lebanon, Eaton, Madison, and Brookfield, and the villages of Hamilton, Earlville, Madison, and Morrisville. Preference will be given to businesses within 10 miles of the Village of Hamilton. Applications due January 27, 2021 at 4pm. For more information and the application click here.

Provisions for individuals include extension of unemployment insurance benefits through March 14, 2021, with additional payments of \$300 per week. Direct payments of \$600 are being delivered to Americans earning up \$75,000 a year, with lesser amounts for those earning up to \$99,000. An extra \$600 is being paid to those with eligible dependents.

While direct aid to state and local governments is excluded from the relief package, there is \$82 billion, which will flow through state governments, to support education. There is also \$69 billion to help state and local governments offset the costs of testing, tracing and vaccine deployment.

- . Vaccines, Testing and Tracing, Community Health and Health Care Provider Support: \$69 billion

• Schools: \$82 billion

• Rental Assistance: \$25 billion

• Nutrition and Agriculture: \$26 billion

• U.S. Postal Service: \$10 billion (loan converted to payment)

• Child Care: \$10 billion • Broadband: \$7 billion

• Additional Provisions: Coronavirus Relief Fund extension; extension of the Employee Retention Tax Credit; special "lookback" for EITC and CTC; Contractor Pay extension.

The stimulus comes at a time when new COVID-19 cases continue to rise, impacting people, straining health care institutions, forcing businesses to make difficult decisions and leading to an increase in workers seeking unemployment benefits. Given the scale of ongoing economic disruption, it is anticipated that Congress and the new administration will attempt to negotiate additional relief or stimulus funding in the coming months. Significant focus is likely to be on aid to state and local governments, infrastructure investments and COVID-19 liability protections for business. CenterState CEO will continue to work with federal, state and regional leaders to advocate for the region's priorities in future legislation.

CENTERSTATE CEO CONTINUES TO TRACK CRITICAL REGIONAL ECONOMIC INDICATORS


The unemployment rate for those living in the Syracuse MSA (Madison, Onondaga, Oswego counties) rose slightly to 6.4% in October, but was still lower than in New York state (9.2%) and lower than the U.S. unemployment rate of 6.9%. The unemployment rate in the city of Syracuse rose by nearly a full percentage point to 10.5% in October; 4.1 percentage points higher than in the broader Syracuse MSA. These upticks in unemployment rates at the city and regional level are the first increase following two months of declines from July peaks of 18.3% in the city of Syracuse and 13% in the Syracuse metro region.

Data adjusted for seasonal changes in the labor force show that overall, there were 290,600 in the labor force in October compared to 295,600 in September. This marked the fourth consecutive month of a labor force decrease and a loss of 24,800 workers since July. From September to October the Syracuse MSA added 900 to the unemployment rolls while overall employment fell by 5,900, and 5,000 workers left the labor force.

Though the impacts are across the entire economy, the greatest impacts from the COVID-19 pandemic continue to be focused on accommodation and food services, retail trade, leisure and hospitality. Total October jobs in the Syracuse MSA were down 10.6% compared to the previous year with accommodation and food services down 20.2%, retail trade down 18.5%, and leisure and hospitality down 18.8%. Jobs in hospitals, utilities, financial activities and manufacturing were all down compared to the previous year, but job loss in these sectors were not as severe as the job losses across the economy as a whole.


Unemployment Rate Syracuse Metro Area

NEW WELLNESS CENTER READY TO EMPOWER WOMEN

CenterState CEO's Northside Urban Partnership (Northside UP), in collaboration with St. Joseph's Health, the YMCA of Central New York, M.S. Hall and Associates, and several neighborhood partners announced the completion of the long-awaited **Northside Women's**

Wellness Center (the Center). Operated by the YMCA, the Center is located at the corner of Butternut and North McBride streets.

This project is an example of how CenterState CEO's Economic Inclusion team successfully uses facilitation models to convene community stakeholders to implement strategies and build programs that empower residents and revitalize neighborhoods. The need for a Women's Wellness Center was identified after a series of health and wellness conversations between St. Joseph's Health and neighborhood residents revealed an alarming trend in which women felt isolated and unable to access outlets of exercise. The Center now offers a welcoming, safe and empowering place for all women to improve their health and the health of their families. The women-only, culturally appropriate space includes fitness equipment, programming and on-site drop-in child watching for mothers using the facility. The project is funded by awards from Trinity Health's Transforming Communities Initiative, the Central New York Care Collaborative, the Mother Cabrini Health Foundation and the Nazareth Fund.

The construction and renovation of the space was delayed for several months due to the COVID-19 pandemic. During this time, additional modifications and

upgrades were made to the HVAC system to ensure the health and safety of all guests in the space. After a July start, the construction was completed in early November. Plans to introduce the Northside Women's Wellness Center to the community include virtual tours and a speaker series slated to launch in February 2021. An in-person soft opening will also be planned in accordance with strict COVID-19 safety protocols and social distancing guidelines for early 2021, with an anticipated grand opening event later in 2021. Designed as an inclusive, holistic wellness space with residents' voices at the forefront, the Northside Women's Wellness Center will be an important resource for women's health in the Syracuse community.


Business Tactics - Recruiting Candidates During a Pandemic

Urban Innovation Award

Given for a trail-blazing activity that includes a visionary, creative, or unusual element.



Heart of Downtown

Nicole Samolis — founder of Epicuse and Sky Armory — lives and works in the Heart of Downtown Syracuse. When Epicuse, a grocery store and cafe along South Salina Street celebrated its grand opening in November 2019, it was the first of its kind in downtown. Just four months later, the business was deemed essential in the pandemic, providing necessary and convenient goods for downtown residents. Epicuse and SKY Armory creatively pivoted in other ways to serve neighbors.

During the summer, Epicuse launched "Wine Down Wednesdays," inviting downtown Syracuse residents, employees and visitors to catch up at its outdoor patio. In the winter, Samolis took a popular one-night event model - Night Market at Sky Armory - and extended it into a month-long holiday shopping experience through The Pop Up Shoppes at Sky Armory. Samolis is being recognized with this award because of her resilient spirit that contributes to a vibrant community.

New York UAS Test Site Completes its Most Technologically Complex Drone Operation to Date

The New York UAS Test Site at Griffiss International Airport in Rome, New York completed phase two of the Federal Aviation Administration's (FAA) unmanned aircraft traffic management pilot program (UPP). UPP Phase Two (UPP2) showcased capabilities and services that will support safe, high-density unmanned aircraft systems (UAS), or drone, operations.

The capabilities demonstrated included: remote identification services that will allow observers to identify nearby UAS, detect and avoid technology to prevent collisions, and public safety operations - pushing the boundaries of unmanned aircraft systems and enhancing Central New York's leadership in the booming UAS industry.

More than 40 people from 13 organizations came together, both physically and virtually, to complete the work outlined in UPP2.

Three weeks of testing included more than 100 live and simulated flights of both manned and unmanned aircraft. The UPP2 team reached its goal of high-density urban drone operations, with a peak density of 18 aircraft (15 live and 3 simulations) in the air at the same time, within 0.2 square miles of airspace over downtown Rome.

New York state continues to invest and support Central New York's surging UAS and advanced technology ecosystem. Support began in 2015 as part of Gov. Andrew Cuomo's Upstate Revitalization Initiative, aptly named CNY Rising, which included an unprecedented \$35 million commitment for the creation of a UAS test corridor between Syracuse and Rome. Governor Cuomo announced the completion of the 50-mile UAS corridor in 2019. Thanks to these investments and others, Central New York continues its path of increasing jobs, regional wealth and UAS advancement.


